





### CNIPA Publishes Statistical Data of IP Rights (January to June 2021): Trademark Registrations Rise at an Annual Growth Rate of 41.63%

Recently China National Intellectual Property Administration ("CNIPA") published statistical data of IP rights from January to June 2021. Compared with the same period of 2020, increases were seen in both the number of trademarks registered and the number of trademarks in validity, as shown in the table below:

From January to June 2021, CNIPA received a total of 78777 trademark opposition petitions and concluded 82074 cases of review on trademark oppositions.

# CNIPA Publishes Statistical Data of IP Rights (January to June 2021): Geographical Indications and Layout Designs of Integrated Circuits

From January to June 2021, CNIPA accepted 11 applications for geographical indication products and approved 87 geographical indication products. Meanwhile, CNIPA approved 3355 market entities to use the special sign for geographical indications and approved registrations of 254 geographical indications.

From January to June 2021, CNIPA accepted 8196 applications for registration of layout designs of integrated circuits and issued certificates for 7627 layout designs of integrated circuits.
