



From January to August 2023, China National Intellectual Property Administration accepted 46,400 PCT international patent applications. Of these, 43,100 were submitted by domestic applicants.

From January to August 2023, Chinese applicants submitted 1,226 international design applications. From January to August 2023, 973 public international applications for design were designated to China.

Trademark

CNIPA publishes Statistics on Trademarks (January to August, 2023)

During the captioned period, 4,755,000 trademark applications were filed in China, and 2,718,000 trademarks were registered. As of the end of August 2023, registered trademarks in force reached 44,781,000.

Also during the captioned period, the CNIPA received 4,071 Madrid international trademark registration applications filed by Chinese applicants.
